

# **CLINICAL SERVICES**

University of Florida Health Physicians, or UFHP, is responsible for managing the clinical component of the University of Florida College of Medicine faculty practice plan. Each clinic has a medical director and an Ambulatory Care Unit, (ACU) manager who oversees the day-to-day operations of the clinic.

Our physicians work closely with patients who visit the **Equal Access Center** and the **Mobile Outreach Clinic** to give them high-quality care. The department hosts patient care outside of the regular business day through our Extended Hours clinic.

UF Health Family Medicine - Jonesville clinic offers comprehensive care to patients ages seven and older. The physicians at Jonesville provide a wide variety of services, including treatment of acute and chronic illnesses, minor surgeries including vasectomies, gynecology, dermatology, health maintenance, cryosurgery, colposocopy, skin care, immunizations, and procedures such as placements of IUDs and nexplanons. On site physicians provide preventive health care including gynecological examinations, sports physicals, and routine adult and child physical examinations. Conditions including diabetes mellitus, hypertension, coronary artery disease, osteoarthritis, thyroid issues, asthma, and allergies are also treated.

# **UF HEALTH STUDENT HEALTH CARE CENTER**

The mission of the Student Health Care Center (SHCC) is to help all students achieve maximum physical and emotional health so they may fully participate in the numerous educational and personal growth opportunities available at UF. The UF Student Health Care Center has been providing care to students since the institution's inception in 1905 and has been in the historic Infirmary Building since 1931. We currently have services available to over 52,000 students. Services are provided in three Primary Care teams, SMAC (Sports Medicine and Acute Care) Clinic, Women's Clinic, and Special Clinics (Allergy Injection Clinic, Flu shots, and other immunizations). Additionally, we have satellite clinics at SHCC @ Shands and



SHCC @ Santa Fe College. Our physicians and advanced practice clinicians are board-certified and our organization is accredited by the Accreditation Association for Ambulatory Health Care, Inc. Services provided include general medical, sports medicine and acute care, concussion care, women's health, and sexual health. Psychiatric services located at the Counseling Wellness Center include LGBTQ+ care, eating disorders, nutrition, and travel services. Telehealth care is available for some medical problems. Physical Therapy services are provided on-site through an agreement with UF Health Physical Therapy. We have on-site Laboratory services, Radiology & ECG services, and a full-service Pharmacy. In partnership with the Alachua County Health Department, free STI screenings are provided for UF students on-site through the GYT (Get Yourself Tested) clinic. Occupational Medicine and Worker's Comp is provided at our SHCC @ Shands clinic for UF employees.

# **UF HEALTH WOUND CARE AND HYPERBARIC CENTER**

The UF Health Wound Care and Hyperbaric Center's modern facility includes four outpatient wound treatment rooms and three monoplace hyperbaric oxygen chambers. Most of the wounds treated are chronic and include diabetic ulcers of the lower extremity, venous leg ulcers, pressure ulcers, arterial ulcers, non-healing surgical injuries, and other wounds. Services include ankle-brachial indices, transcutaneous oxygen testing, debridement, biopsies, wound cultures, dressings to promote moist wound healing, compression wraps, negative pressure wound therapy, total contact casting, advanced tissue therapies, and Xpansion skin grafting.



In the outpatient setting, hyperbaric oxygen therapy is most commonly used to treat delayed radiation injury, diabetic foot ulcers with osteomyelitis or gangrene, chronic and refractory osteomyelitis, comprised skin grafts and flaps, and necrotizing soft tissue infections. The center focuses on a case manageent model and closely monitors patient outcomes. As a result, the UF Health Wound Care and Hyperbaric Center was presented with the 2016 Center of Distinction and 2017 and 2018 Robert A. Warriner, III Center of Excellence by Healogics.

# BLMP PROGRAM

### PROGRAM FACULTY

### **EDUCATION**

Throughout the 2018–2019 academic year, the Bioethics, Law and Medical Professionalism (BLMP) faculty delivered engaging instruction on bioethical issues to medical students, residents, fellows, graduate and undergraduate students, and health care professionals in the community.

The BLMP faculty provide the majority of the bioethics education for medical students through the Clinical Ethics, Law, and Professionalism thread; this curriculum is designed to teach students how to identify, analyze, and discuss ethical issues they will encounter as physicians. This education consists of lectures and regular small group sessions with Collaborative Learning Groups (CLGs) during the first and second years of medical school. Additionally, Professor William Allen teaches a required course for first-year medical students each fall called Discovery, Research and Health, where students learn about research ethics.

In Spring 2019, the BLMP program introduced the Medical Ethics and Law Discovery Pathways Track in the University of Florida College of Medicine. Since the track was launched, 11 students have joined. The Discovery Pathways Track Program is an optional program for medical students to build a portfolio of accomplishment and scholarship in a defined area acceptable to pathway to leadership. The goals of the Discovery Pathways are to expose medical students to research and begin training as Clinician Scientists. Each Discovery Pathway allows students to complete an extended research project within their four year medical school curriculum and still graduate with their classmates.

The Medical Ethics and Law track is designed to provide students with a more in-depth look at legal and ethical issues in patient care and/or research. Through practical, active learning opportunities such as attendance at ethics committee and IRB meetings, academic conferences, participation in ethics consultation for real (not simulated) patients, among other offerings, students will learn not only how to analyze ethical issues in research and patient care but also how to develop scholarship in law and bioethics. This track also requires students to complete an extended research project related to bioethical issues under the guidance of a BLMP faculty mentor.

Third-year medical students participated in ethics case conferences led by BLMP faculty throughout their clerkship rotations with Family Medicine/Ambulatory Care, Pediatrics, and Psychiatry. Moreover, BLMP faculty facilitated professionalism workshops for students rotating through the Family Medicine/Ambulatory Care clerkships. Fourth-year medical students received instruction from program faculty during senior elective courses and ethics case conferences in the Geriatrics Clerkship. These individual faculty highlights below describe these electives in further detail.

The BLMP faculty expanded the ethics curriculum they developed in 2017-2018 to include all three cohorts of family medicine residents. This curriculum centered around small-group discussions on end-of-life care, medical error, informed consent, confidentiality, and professionalism.

### ADDITIONAL FACULTY TEACHING HIGHLIGHTS

- Professor William Allen codirected and taught senior medical student electives with Dr. Moseley titled
  "Advanced Issues in Medical Ethics and Law" and "Financial, Business, and Health Systems Aspects of
  Medicine." In the fall semester, Professor Allen codirected the Ethics in Genetics graduate course. During
  the spring, Professor Allen directed and taught an Ethical/Policy Issues in Clinical Research elective for
  UF graduate students. He also presented lectures to pharmacy students throughout their required the
  Law and Ethics thread. In Summer 2019, Professor Allen began working on a research project with a
  Medical Ethics and Law track student.
- Dr. Ray Moseley codirected and taught senior medical student electives with Professor Allen titled "Advanced Issues in Medical Ethics and Law" and "Financial, Business, and Health Systems Aspects of Medicine." In Spring 2019, he was invited by the IRB to serve in an additional role guiding research teams through the IRB application and review process. He also presented ethics material to high-achieving high school students enrolled in the Student Science Training Program (SSTP), a seven-week research camp hosted by the UF Center for Precollegiate Education and Training. Throughout the year, Dr. Moseley facilitated monthly ethics workshops for internal medicine residents and taught small group sessions of the Putting Families First: Interdisciplinary Family Health course. In Summer 2019, he began working on research projects with three students in the Medical Student Research Program (MSRP) and the Medical Law and Ethics track.
- Professor Lauren Solberg continued mentoring a Medical Student Research Program (MSRP) student
  from Summer 2018, and began working with a new MSRP student in Summer 2019. She directed the
  graduate course: Law and Ethics of Aging, and expanded the curriculum of her Career Pathways for
  Research Professionals class to become a 2-credit class for the coming year. In May 2019, Professor
  Solberg was awarded a Faculty Enhancement Opportunity grant to pursue professional development
  through Cornell University. In addition, she taught small groups of students in the Putting Families First:
  Interdisciplinary Family Health course for students across the UF Health Science Center.

### **SERVICE**

BLMP program faculty comprise the core team of ethics consultants for UF Health. The UF Health ethics consult service is a free service offered to patients, family members, and healthcare professionals with ethical concerns about making medical decisions. The consultant on call may work independently or with other team members to navigate issues such as treatment plan conflicts, informed consent, social worker proxies, decisional capacity, advance directives, and end-of-life care issues.

### ADDITIONAL FACULTY SERVICE HIGHLIGHTS

- Professor William Allen served on the planning committee for UF Health's Celebration of National Healthcare Decisions Day. The work group met several times between January and April 2019 to organize countywide events promoting patient empowerment and advance care planning. He also participates in the Florida Comprehensive Assessment and Remedial Education Services (FL CARES) Program, where he assists UF physicians who review cases referred from the Florida Board of Medicine to ensure that their medical and clinical ethical skills are appropriate for current practice. Professor Allen joined the Data Safety Monitoring Board (DSMB), part of an FDA and NICHD-funded research project led by Dr. Peter Stacpoole.
- Dr. Moseley was the first president and founder of the Florida Bioethics Network (FBN). Throughout this year, he has served as a senior board member. In this role, he worked to bolster the communication efforts of the organization, especially through podcasts, newsfeeds, and an updated FBN website.
- From Summer 2018 through Spring 2019, Professor Solberg served as past president of the UF College of Medicine Faculty Council, and took on the role of Faculty Council Representative for the Department of Community Health and Family Medicine. Enshrining the principle of shared governance, the Faculty Council liaises between College of Medicine faculty and UF administration.

# RESIDENT EDUCATION PROGRAM

### **PROGRAM PROFILE**

The University of Florida Family Medicine Residency program has made a significant impact on the care provided to patients in Alachua County and northern Florida since 1973.

We have graduated **311** residents from the family medicine program who have entered the workforce as providers of comprehensive medical care, academics and specialty care in geriatrics, emergency medicine, hospital-based medicine, and sports medicine. The program trains competent, compassionate, ethical, and professional physicians who provide comprehensive care to patients in a continuity of care model. Emphasis is placed on practical and direct patient care-based training in addition to didactic teaching to enhance the learning environment.

The residency program is also committed to supporting each resident in his or her educational endeavors, whether the resident selects a clinical path or moves on to a fellowship, academic medicine or research. New initiatives in the program continuously improve on high-quality care and patient safety, as well as enhanced educational and research opportunities. The department's mission is to instill in residents the love of lifelong learning by providing the framework and tools to ensure success in the long-term art and practice of medicine.

### **ACTIVITIES AND HIGHLIGHTS FOR 2018 - 2019**

The Family Medicine Residency program had a great academic year, with over 1,700 total applicants. The department filled a total of 102 interview slots and welcomed nine talented residents to the program. Five of the eight graduating residents will be staying in Florida. Four will be practicing outpatient medicine, one will be continuing on to a sports medicine fellowship here at UF and three practicing hospital medicine.

During July, the upper-level residents also transitioned to a "mini-block" schedule that was created in hopes of allowing residents to be fully engaged in the clinic environment as well as other rotations. All residents continued working toward improving the number of colon cancer screenings and flu and pneumococcal vaccination rates, as well as promoting tobacco cessation. Second and third year residents continued being highly involved in department projects focused on hospital readmission, patient satisfaction, physician well-being, and advance directives.

During December, employees at the Main Street clinic hosted their second annual Holiday Luncheon for patients. It was an opportunity for faculty, residents, staff, and nurses to come together to serve patients a warm meal during the holiday season. The luncheon was highly successful, and they look forward to hosting the celebration once again during the upcoming holiday season.







# SPORTS MEDICINE PROGRAM

### **PROGRAM PROFILE**

The University of Florida has a history of outstanding athletics and a reputation for excellence in medicine. The UF Sports Medicine Fellowship combines elements of both to create an outstanding educational experience for the sports medicine fellow. This ACGME accredited fellowship adds to the Department of Community Health and Family Medicine's long legacy of excellence in education.

Established in 2007, the program's goal is to produce excellent primary care sports medicine physicians equipped for a lifetime of learning who are prepared for a successful and fulfilling career in sports medicine.

The 12-month curriculum offers abundant exposure to athletic teams and events at the University of Florida and greater North Florida area. Most learning activities take place at the UF Student Health Care Center, UF Orthopedics and Sports Medicine Institute, and the University of Florida Athletic Association's training rooms and facilities on the UF campus. The fellowship program accepts up to three fellows each year and is open to applicants trained in family medicine, physical medicine and rehabilitation, internal medicine, emergency medicine, and pediatrics. Applicants residency training must be from an ACGME-accredited residency program.

### SPORTS MEDICINE FELLOWS

On July 1, 2019 the department officially welcomed Gary Allen, DO, Joshua Altman, MD and Nicole Pitts, DO to the Sports Medicine Fellowship program. Dr. Allen joins us from the UF Family Medicine Residency program, Dr. Altman joins us from UF Emergency Medicine Residency and Dr. Pitts joins us from Pittsburg Family Medicine Residency. They are excited to be part of the Gator Nation and participate in many levels of the fellowship program.

# **COMMUNITY HEALTH**



### **EQUAL ACCESS CLINIC**

Equal Access Clinic Network (EACN) had our most successful year thus far through 2019, and we are excited to continue that progress into 2020. Over the last year, EACN saw increased numbers of patients network-wide. We were able to offer and pay for over 1,600 labs through Quest Diagnostics. We are especially proud of the addition of endometrial biopsy services to Women's Night at the Main Street Clinic, and pap smears are now offered at all four primary care clinic sites due to our continued and improving relationship with UF Health Department of Pathology. By opening our Dermatology Clinic, which has successfully performed skin biopsies and interpretation for two consecutive months, and by purchasing a new slit lamp for our Ophthalmology Clinic, we have made significant expansions in our ability to serve patients.

We continue to develop Equal Access as a patient-centered medical home by ensuring accessible, quality and comprehensive care that addresses both our patients' health needs and obstacles to receiving care. The enthusiasm for the clinics among faculty of the Department of Community Health and Family Medicine, as well as our numerous Health Science Center professional schools, also continues to grow, and we greatly appreciate the support. We are encouraged that these successful partnerships continues to improve our students' understanding of the social determinants of health in our local community. Importantly, the leadership demonstrated among our officers is outstanding and indicative of their passion for serving their community, as shown by our record number of patient encounters in 2018-2019.

### **NETWORK HIGHLIGHTS**

Across four primary care sites and 14 speciality clinics, we have extended the capacity of our services for a total of over 2,400 patient visits.

Our primary care clinic sites are strategically located in areas of medical need:

- Anthem: 468 patient visits, an increase of 38% from 2017-18.
- Bartley Temple: 405 patient visits.
- Eastside: 421 patient visits.
- Main Street: 697 patient visits.

To provide comprehensive care by screening and treatment of our underserved community members, the clinic has:

- Administered 323 HIV tests, an increase of 34% from 2017-2018.
- Counseled 186 free 30-minute sessions with trained psychologists for mental health needs.
- Screened 1,147 patients network-wide for depression and substance use disorders.
- Treated 506 physical therapy patients with an average of 14 patients per night.

To extend our continuity of care, our specialty services continue to expand:

- Our pediatric clinic volunteer base has expanded immensely with a biannual surge of visits to care for the 46% of our pediatric patients presenting in 2018 who may be Medicaid-ineligible.
- Ophthalmology faculty have examined 42 patients, up from 3 to 8 patients seen per clinic night due to generous donor contributions to purchase an additional slit lamp and chair.
- Social Work specialty clinic has seen 95 patients, now twice monthly at our Main Street site.

### **2019-20 CLINIC GOALS**

### External

- Continue to operate a student run network of general medical and specialty clinics.
- Recognize and steward volunteers.
- Form new partnerships and identify community social resources for referrals.
- Annually report to our cherished donors, administrative supporters, and champions.

### Internal

- Increase capacity of general medical and specialty clinics by 10% each year.
- Develop official volunteer training in medical and social prescriptions.
- Regular meetings with UF faculty to discuss clinic operations and care quality.
- Regularly present research at local and national meetings and peer-reviewed publications.

We look forward to another productive year of community partnerships and innovations to increase access to available resources in Gainesville and Alachua county, keeping with the Equal Access Clinic Network mission: to provide quality, comprehensive healthcare for all.

# **COMMUNITY HEALTH**

### MOBILE OUTREACH CLINIC

The Mobile Outreach Clinic (MOC) was established in 2010 in response to a growing recognition that many underserved patients in Gainesville were unable to access medical care due numerous socio-economic barriers, especially transportation. The clinic strategically locates itself in Gainesville neighborhoods/common areas with high concentrations of uninsured and under-insured residents as well as those experiencing substantial health disparities. The clinic is staffed daily by a clinic nurse, Trinity Cromwell; two ARNPs, Michelle Nall and Sandy Frost; and a team of volunteer PAs and MDs who provide comprehensive primary care services. The providers rotate on a recurring schedule at the same site in order to ensure high levels of continuity. Additionally, the MOC utilizes the skills of approximately 50 undergraduate volunteer Care Coordinators who help with day-to-day operations of the bus as well as offsite phone-based follow-up with patients to help ensure follow through with care plans. The MOC also hosts a robust educational program for medical, pharmacy and PA students of all levels. During their rotations these students learn how to provide care in settings where social determinants of health play a disproportionately high role in health outcomes. Graduate education is facilitated on the bus through partnerships with College of Pharmacy PGY-1 residents as well as residents within



the departments of Family Medicine, Internal Medicine and Pediatrics. Finally, we also help provide space and support to the Monday and Wednesday night EAC clinics at Anthem church and Bartley Temple.


This past year was full of exciting accomplishments for MOC and its partners. We are especially proud of the expansion of our BESTYou and BESTYou Jr programs. As of June 2019 we have delivered the program to 140 individuals in a variety of locations including homes, churches, libraries and public schools. In addition we have hosted the program in rural areas including Brooker and Old Town. We have further expanded our educational mission by adding service learning experiences for first and second year students from the local/global health equity track as well as for third year students on the Family Medicine Clerkship. We are also very proud of our scholarly accomplishments as we had five presentations at national conferences this year and also two articles published in peer reviewed journals.

### 2019-20 CLINIC GOALS

The Mobile Outreach Clinic hopes to achieve the following goals during the next fiscal year:

- **Education:** Expand our social determinants of health curriculum to include more individualized learning and continue to achieve outstanding evaluations for our elective. Help push the College of Medicine as a whole towards incorporation population health topics into all parts of the curriculum.
- Community outreach: Develop a Community Health Worker training program to equip residents throughout the state and here in Alachua county with skills to promote healthy living in their local communities.
- Quality improvement and research: Explore the use of Community Health Workers for reducing health disparities.
- Long-term sustainability: Hold the first annual Grassroots Gala to fundraise for our Mobile Outreach Clinic endowment.

# **COMMUNITY HEALTH**

### BEHAVIORAL MEDICINE PROGRAM

The behavioral medicine faculty and staff participate in projects and activities involving all significant missions of the department and the UF College of Medicine, including teaching and administrative activities, direct patient care services, consultations, and research/scholarly activities. Regarding educational programs, behavioral medicine faculty undertake the development and implementation of medical, and educational programs for family medicine residents, medical students, community practicing physicians, and academic physicians.

One primary focus of the program is an curriculum designed to educate medical trainees in various aspects of the biopsychosocial model of care, including home visits and office-based lifestyle modification (e.g., smoking cessation, healthy exercise patterns). Other areas of particular emphasis include 360-degree evaluation of resident performance, including physician-patient communication skills and professionalism.

The behavioral medicine program is an integral part of the clinical mission of the department. The faculty and staff of the program provide psychotherapy and evaluation services to patients referred by the physician faculty of the department and by the family medicine residents.

### **PROGRAM OBJECTIVES**

Some behavioral medicine educational activities include:


- Co-leading small groups during the "Essentials of Patient Care" and "Interdisciplinary Family Health" sections of the medical school curriculum.
- Workshops and lectures on behavioral medicine topics during third- and fourth-year clerkships.
- Ten to twelve lectures on human behavior and mental health presented as part of the Residency program didactic sessions for third-year Family Medicine and Ambulatory Care clerkship and fourth-year required Medicine rotation students.
- Behavioral Medicine program faculty consult and precept third- and fourth-year medical students
  regarding the social agency needs of patients, the assessment of psychological disorders, and the
  management of family conflict.

# **QUALITY AND PATIENT SAFETY**

This past fiscal year saw significant improvements in several key quality areas for both the UF Health Family Medicine clinics and the Family Medicine inpatient service. The Vizient Quality and Accountability Scorecard identifies and promotes quality and safety across a variety of patient sectors. The scores, based from 1 to 5 stars, equalize ranking across different organizations. During the most recent ratings period, UF Health ranked with an overall score of 38.06%, which is a high 3 star rating. Family Medicine, grouped with Internal Medicine for Vizient, improved over the last year for Mortality and Excess Days. They hospital continues to work with departments to improve Efficiency, Safety, Effectiveness and Patient Centeredness. The hospital hopes to break the 4 star ranking during the 2019 – 2020 fiscal year.

One area to be celebrated is the improvement of the UF Health Family Medicine - Eastside Press Ganey Patient Satisfaction Scores. They rose from an overall rank of 57% in the second quartile in the last quarter of FY18 to 84% in the third quarter of FY19 (the last quarter of data at time of the Annual Report publication.) This places Eastside into the first quartile to join the UF Health Family Medicine clinics at Haile, Jonesville and Springhill. The biggest jump in scores was for the "Likelihood of Recommending Practice" that jumped from a ranking of 42 to 89.

Finally, our clinics are held accountable for the 30 day readmission rate using the Readmission Quotient developed specifically for the UFP clinics. Over the 12-month period for FY19, the Readmission Quotient mean was 15.72% with a department low of 12.37% in September and a high of 18.68% in May. Each clinic now has an RN Health Coach whose priority has been to follow up with patients once discharged from the hospital to identify patients appropriate for a Transitional Care Visit. The focused effort of the RN Health Coaches along with other activities such as the Golden Letter, Transition of Care Clinic, and others have been instrumental in this downward trend in the Readmission Quotient.
